

CITY OF ARROYO GRANDE WATER EFFICIENT WASHING MACHINE REBATE PROGRAM

The City of Arroyo Grande offers rebates on qualifying clothes washing machines.


Program Background:

More than 20% of all water consumed in a home is used in the washing machine. Running a conventional washing machine can use more than 50 gallons of water per cycle. However, there are high-efficiency models that use 50% less water and energy. Most full-sized high-efficiency clothes washers use 18-25 gallons of water per load. **Receive a \$200 refund with the purchase of a new energy and water efficient washing machine. Continue to save money each month on your water and energy bills!**

Here's how to qualify for the washing machine rebate:

- The City of Arroyo Grande must provide water service to your residence.
- Rebates are based on the amount of water the washing machine uses. The City will only rebate Tier III washers that have a water factor of 4.0 or less. Verification of the water factor from the retailer or from a reputable online source is required.
- You must submit a rebate application and verification of purchase, model, residency and water factor in order to receive a City rebate.

CITY OF ARROYO GRANDE WATER EFFICIENT WASHING MACHINE REBATE PROGRAM

This program is subject to change without notice and is subject to the availability of funding.

PURPOSE:

The intent of the Water Efficient Washing Machine Rebate Program is to encourage the use of water efficient appliances, with the added benefits of energy efficiencies.

REQUIREMENTS:

PLEASE READ THIS INFORMATION CAREFULLY. In order to receive a City rebate for purchasing a qualifying clothes washing machine, the applicant must completely fill out the application and comply with the requirements on this form. Failure to do so may result in disqualification.

1. The property receiving the washer must be a water customer of the City of Arroyo Grande.
2. The washer must have a **Water Factor of 4.0 or less** to qualify (applicant must provide verification with the application from either the retailer or online search).
3. The purchase must be made on or after January 1, 2016. The City will not honor rebates for used or reconditioned washers, or washers purchased prior to the above date.
4. The reverse side of this form must be completely filled out.
5. Applicant must attach a legible copy of a valid, dated sales receipt to this application.
6. The washer must be installed in accordance with all relevant building codes prior to submittal.
7. Rebates shall be on a one-time basis per address or customer.
8. A Public Works Department staff member will inspect the property to verify model and installation.

REBATE:

If all of the requirements listed above are satisfied, a rebate of \$200 will be mailed to the applicant. The City of Arroyo Grande reserves the right to terminate this program at any time, for any reason.
