NOTICE OF PUBLIC HEARING**

NOTICE IS HEREBY GIVEN that the Arroyo Grande Planning Commission will conduct a public hearing on **TUESDAY, JUNE 1, 2021 at 6:00 p.m.**, or soon thereafter, to consider the following item:

CONSIDERATION OF GENERAL PLAN AMENDMENT 20-001; CIRCULATION ELEMENT UPDATE AND ADOPTION OF A MITIGATED NEGATIVE DECLARATION; LOCATION – CITYWIDE. The Planning Commission will discuss the proposed City of Arroyo Grande Circulation Element Update (“Update”). The Circulation Element sets standards for streets and highways, levels of service, multi-modal circulation, and transportation systems. The Update includes change in the Level of Service (LOS) Policy from the current threshold of LOS C to LOS D, new bicycle Level of Traffic Stress Policy, strengthen multimodal policies throughout, including Complete streets, Roundabouts and Safe Route to School Policies. The updated has added a Vehicle Miles Traveled Policy, a refined multimodal improvements beyond the current Bicycle & Trails Master Plan. The update has also incorporated an Existing Conditions Background Report and summary text. The Circulation Element Update projects traffic related growth out to the year 2040. As the growth increases, traffic impacts will cause deterioration to the Level of Service (LOS) to various road way, intersections and interchanges. The Circulation Element Update will identify the proposed projects needed to improve the LOS. A mitigated negative declaration has also been prepared and will be adopted as part of this update.

Due to concerns regarding the COVID-19 pandemic, the City of Arroyo Grande is conducting all public meetings via teleconference, until further notice. The Planning Commission meeting can be viewed on Government Access Channel 20. The meeting will also be streamed live online from the City’s website at www.arroyogrande.org and www.slo-span.org.

Members of the public may submit written comments prior to the meeting via US Mail delivered to the Community Development Department, 300 E. Branch Street, Arroyo Grande, CA 93420, or by email to pc-publiccomment@arroyogrande.org. During the public hearing, public comment will be limited to three (3) minutes per speaker, pursuant to current meeting procedure.

The Planning Commission may also discuss other hearings or business items before or after the item listed above. If you challenge the proposed action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Planning Commission at, or prior to, the public hearing. Failure of any person to receive the notice shall not constitute grounds for any court to invalidate the action of the legislative body for which the notice was given.
