NOTICE OF PUBLIC HEARING**

NOTICE IS HEREBY GIVEN that the Arroyo Grande Planning Commission will conduct a public hearing on **TUESDAY, OCTOBER 19, 2021 at 6:00 p.m.**, or soon thereafter, to consider the following item:

CONSIDERATION OF AMENDED CONDITIONAL USE PERMIT 21-001; INSTALLATION OF A BACK-UP GENERATOR AND AMENDMENT OF LEASE AREA AT AN EXISTING TELECOMMUNICATION FACILITY; LOCATION – 581 BRANCH MILL ROAD; APPLICANT – T-MOBILE WIRELESS; REPRESENTATIVE – J5 INFRASTRUCTURE PARTNERS

The Planning Commission will consider an application for an Amended Conditional Use Permit to add an emergency backup generator to an existing telecommunication facility at 581 Branch Mill Road.

In compliance with the California Environmental Quality Act (CEQA), the Community Development Department has determined that the original project was categorically exempt pursuant to Section 15301 of the CEQA Guidelines regarding existing facilities.

Due to concerns regarding the COVID-19 pandemic, the City of Arroyo Grande is conducting all public meetings via teleconference, until further notice. The Planning Commission meeting can be viewed on Government Access Channel 20. The meeting will also be streamed live online from the City's website at www.arroyogrande.org and www.slo-span.org.

Members of the public may submit written comments prior to the meeting via US Mail delivered to the Community Development Department, 300 E. Branch Street, Arroyo Grande, CA 93420, or by email to pc-publiccomment@arroyogrande.org. During the public hearing, public comment will be limited to three (3) minutes per speaker, pursuant to current meeting procedure.

The Planning Commission may also discuss other hearings or business items before or after the item listed above. If you challenge the proposed action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Planning Commission at, or prior to, the public hearing. Failure of any person to receive the notice shall not constitute grounds for any court to invalidate the action of the legislative body for which the notice was given.
