

## CITY OF ARROYO GRANDE PLANNING COMMISSION NOTICE OF PUBLIC HEARING

**NOTICE IS HEREBY GIVEN** that the Arroyo Grande Planning Commission will conduct a public hearing on **TUESDAY**, **MAY 16**, **2023 at 6:00 p.m**., or soon thereafter, to consider the following item:

CONTINUED CONSIDERATION OF DEVELOPMENT CODE AMENDMENT 23-001; AMENDMENTS TO TITLE 16 OF THE ARROYO GRANDE MUNICIPAL CODE REGARDING SAFE PARKING SITES; LOCATION – CITYWIDE. The Planning Commission will continue to discuss the proposed amendments to the Arroyo Grande Municipal Code (AGMC) regarding the permitting of parking lots in the Public/Quasi-public and Industrial Mixed-Use zones as Safe Parking Sites. The proposed ordinance amendments will establish a permitting process, standards, and regulations for Safe Parking Sites on eligible parcels.

In compliance with the California Environmental Quality Act (CEQA), the Community Development Department has determined that the ordinance update is categorically exempt pursuant to Sections 15301 of the CEQA Guidelines regarding projects involving alterations to existing facilities.

This Planning Commission meeting is being conducted in a hybrid in-person/virtual format. Members of the public that prefer to participate virtually may do so by joining the Zoom meeting option. If you challenge the proposed action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Planning Commission at, or prior to, the public hearing. Failure of any person to receive the notice shall not constitute grounds for any court to invalidate the action of the legislative body for which the notice was given.
