Information Regarding Extensions of Lake or Streambed Alteration Agreements

The holder of an agreement ("holder") may request the Department to extend the term of a Lake or Streambed Alteration Agreement ("agreement"), provided the request is submitted to the Department in writing prior to the agreement's expiration.

If the request is not submitted prior to the agreement's expiration, the Department will be unable to accept the request. In that case, the holder will need to notify the Department in accordance with Fish and Game Code section 1602 or section 1611 and obtain a new agreement in order to begin or continue the work covered by the expired agreement.

If the holder submits an extension request prior to the agreement's expiration, the agreement may remain in effect until the Department acts on the request or for one year after the agreement expires, whichever period is shorter.

The term of an agreement, whether regular or long-term, may only be extended one time.

In order to request an extension, the holder should complete and submit the attached Extension Request form or a letter that includes the information on the form to the Department regional office that serves the county where the project is located.

For more information on extensions, see Fish and Game Code section 1605.

Note: If the agreement was issued by the Department prior to January 1, 2004, extensions are governed by former Fish and Game Code section 1601(g) or 1603(g), pursuant to which the Department may extend an agreement more than one time.
